

SCHEDULE OF STUDENT FEES – SPORTS DEVELOPMENT PROGRAM (2024)

Student Fees

Student Fees set out in the Schedule of Student Fees cover:

- Tuition expenses
- Annual uniform allocation
- Some incursions/excursions
- Student insurance
- Notebook computer, containing all coursework (no textbooks are required to be purchased). The notebook may be retained by the student at the completion of Year 12 provided all Student Fees have been paid in full with a final payment of \$5 to be invoiced at the end of Year 12.

Please note that charges for optional camps, excursions and programs are payable in addition to the Student Fees.

Returning students

During Semester 2 each year, parents/guardians of returning students will be required to pay a Re-Enrolment Deposit of \$1,000. This deposit is payable in two instalments of \$500 and forms part of the Student Fees:

1. The first Re-Enrolment Deposit instalment of \$500 is payable by 31 October 2023 to confirm and secure the student's place for the following year. The amount paid will be deducted from the total Student Fees charged for the new school year. *This instalment is non-refundable and non-transferable.*
2. The second Re-Enrolment Deposit instalment of \$500 is payable by 3 December 2023. The amount paid will be deducted from the Student Fees charged for the new school year. *This instalment is non-refundable and non-transferable.*

New students

Upon receipt of a completed Admission Form confirming a student's enrolment at SEDA College WA, an Enrolment Deposit of \$1,000 is to be paid. This deposit is payable in two instalments of \$500 and forms part of the Student Fees:

1. The first Enrolment Deposit instalment of \$500 is payable upon acceptance of a place for the student at the College (at time of enrolment). The amount paid will be deducted from the total Student Fees charged for the new school year. *This instalment is non-refundable and non-transferable.*
2. The second Enrolment Deposit instalment of \$500 is payable by 31 October 2023. The amount paid will be deducted from the Student Fees charged for the new school year. *This instalment is non-refundable and non-transferable.*
3. For any enrolments received after 31st October 2023 the \$1,000 Enrolment Deposit is payable. The amount paid will be deducted from the total Student Fees charged for the new school year. *This instalment is non-refundable and non-transferable.*

Payment of Student Fees

Parents/guardians will be invoiced for the Student Fees once, in Term 1.

The balance of the Student Fees, after the (Re-)Enrolment Deposit, is payable by one of the following methods:

- in full by 3 December 2023, attracting an Early Payment Discount (refer below)
- in 9 monthly payments, commencing in January of the school year
- in 19 fortnightly payments, commencing in January of the school year

Each family's preferred payment option should be nominated via the College's B-Point link provided to parents in term 4. Payment Plans from previous years will **not** carry forward.

All accounts are to be paid in full by **30 September** of each school year to ensure the College can meet its financial obligations to both staff and external suppliers. The College is unable to extend further Credit Terms to families.

Early Payment Discount

A discount is available for early payment of Student Fees. For all Student Fees paid in full by 3 December a discount of 5% of the total Student Fees applies. Please note the deposit schedule still applies.

Sibling Discount

A 5% discount applies to the total Student Fees of the second and subsequent members of a family who are/were at the College. It does not apply to the first family member or to students in receipt of any other concession or scholarship.

The Sibling Discount will be applied as a credit to the accounts of the second and subsequent members in Term 1.

Concession Discount

Parents/guardians applying for a Concession Discount must provide a copy of the completed SAS Application Form along with a copy of the eligible concession card, to be witnessed by SEDA College Finance at the first MyPlan meeting or via appointment, no later than 25 March, and are subject to approval by the Department of Education, Western Australia. Please note that Concession Discounts cannot backdated.

Payment options

Student Fees can be paid by:

- EFT
- Direct debit from a credit card (Mastercard or Visa) or nominated bank account

Payment can be made in full or on a Payment Plan. Under a Payment Plan, payments will be scheduled either monthly or fortnightly by SEDA College Finance on the dates set out in Appendix 2.

Where Student Fees are paid on a Payment Plan and the direct debit option is selected, a \$20 charge will be incurred in circumstances where the direct debit payment is declined by the nominated account. If this occurs, the charge will be added to the parent's account.

Withdrawal Charges

Notice in writing must be given to the Registrar for any student's withdrawal or Student Fees may be charged or forfeited (as the case may be) in lieu of notice. The Registrar can be contacted via email at registrar@seda.wa.edu.au.

For any withdrawals received after 31st October withdrawal charges apply, as indicated in Appendix 1 - Withdrawal Charge.
