2027 SCHEDULE OF FEES

FEES

Current year fee schedule – please refer to Annexure 1 for Sports Development Program and Annexure 2 for Construction and Trade Program.

Tuition fees include: tuition expenses, annual uniform allocation, some incursions/excursions, student insurance and a student laptop. At the completion of Year 12 the laptop can be retained by the student for \$1, provided all other tuition fees are paid in full.

Note charges for optional camps, excursions, programs and micro credentials are additional to the Tuition Fees.

All fees need to be up to date to purchase Ball, Graduation tickets for parents and extracurricular activities.

ENROLMENT FEE

New Students

Upon receipt of a completed Admission Application confirming a student’s enrolment at SEDA College WA, an enrolment fee of \$1,000 is payable.

PAYMENT OF SCHOOL FEES

The terms of the Enrolment Agreement places the responsibility of ensuring fees are paid in a timely manner (and in accordance with an annually approved payment arrangement) on the parent(s)/caregiver(s) who have signed the enrolment agreement, for the duration of the child’s enrolment at the College.

Please Note: All College fee balances must be finalised by no later than 19 September 2026.

DISCOUNTS & CONCESSIONS

Early Payment Discount

A 5% discount will be applied to the tuition fee where fees are paid in full on or before 30 January.

Sibling Discount

A 5% discount will be applied to tuition fee on the second and subsequent members of a family who are or were at the College.

Secondary Assistance Scheme (SAS)

The Secondary Assistance Scheme is available to parents who hold eligible concession cards. Forms are available from the Finance Department. Applicants need to provide proof of eligibility. Once approved a 20% discount will be applied to the Tuition fee.

BURSARIES

Temporary assistance may be available where families experience short-term financial difficulties. If these circumstances arise, reach out to the Finance Department. Such matters are treated in the strictest confidence.

LATE PAYMENT OF FEES

Parents who are experiencing difficulty in paying fees by the due date are encouraged to contact the Finance Department to discuss alternative arrangements for payment.

The College reserves the right to take legal action for recovery of fees not paid. Any expenses, costs or disbursements incurred by the College in recovering any outstanding fees and charges, including debt collection agency fees and solicitor costs shall be recoverable by the College.

WITHDRAWAL OF A STUDENT

Notice in writing must be given to the Registrar for any student’s withdrawal by notifying The Registrar via email at registrar@seda.wa.edu.au.

Please refer to the Annexure’s in Table 2 which outlines the amounts payable should your child withdrawal during the year.

SEPARATED FAMILIES

Family fee accounts are billed to the enrolling parent(s)/caregiver(s) as per the Enrolment Agreement. Where families are separated the College expects the enrolling parent(s)/caregiver(s) to organise their own payment arrangement of fees ensuring that their fees are paid in a timely manner.
